Dear Resident:

I would like to wish everyone a Happy New Year and hope that your new year is going well. 2008 promises to be an exciting year. There will be some positive changes and enhancements to our Village and services.

I am pleased to announce that our bike path will be completed this spring. The bridge on Austin Powder Drive that crosses Beaver Meadow Creek, will start and will be completed this summer. It will look exactly like the one on Pettibone Road over Tinkers Creek. Our streetscape on the South side of Pettibone Road in the downtown area across from the Village Center shops is finished and looks good.

I want to welcome Larry Sylver to his new position of Councilman in Ward 1 and Rodney Blue to the Service Department. Together, residents, administration and council, let us make 2008 a year of which we can all be proud.

Other items that might be of interest are:

Monday is the scheduled day for Glenwillow's pick up of trash and recyclables. Your trash and recyclable items need to be out before 7 AM. Recycled items must be placed in the blue recyclable container. If you put items out on Sunday, do so after 5 PM. When the following holidays fall on a Monday, your pick-up date will be the next day, Tuesday. The holidays are: Memorial Day, July 4th, Labor Day, Christmas Day, and New Year's Day.

If your daughter or your son is a senior this year and will be attending college in the fall, she or he may be eligible for a \$500 one-time scholarship, provided by the Glenwillow Tax Abatements Program currently in place. The student must meet certain criteria to be eligible. Please see the Guidance Counselor at Solon High School for more information.

Chapter 351.12 of the Codified Ordinance Book states "Prohibition Against Parking on Streets or Highways" - "Upon any street or highway outside a business or residence district, no person shall stop, park or leave any vehicle, whether attended or unattended, upon the paved or main traveled part of the street or highway if it is practicable to stop, park or leave such vehicle off the paved or main traveled part of such street or highway..." Now that winter is here, please adhere to the "NO PARKING" signs that are posted on the streets in Glenwillow.

Re: Cleveland Metroparks 2007-2008 Deer Management Program

Dear Mayor Payne:

I am writing to inform you that Cleveland Metroparks will be continuing our deer management program this winter. A portion of South Chagrin Reservation is within the municipal boundaries of the village of Glenwillow, and a deer herd reduction is planned for this reservation. For a few hours on several days during the period of January 7 through February 22, 2008, portions of the reservation will be closed to the public.

The safety protocol that has been successfully utilized by Cleveland Metroparks from the beginning of the program will continue. Deer will be culled by using highly skilled and trained marksmen for the purpose of re-establishment of balanced ecosystems. Safety remains the number one goal. Your police department will be notified prior to the initiation of specific culling within South Chagrin Reservation. The reservation will be posted/signed and closed completely during the management program. All shots will be fired from elevated truck or tree-mounted platforms using noise-suppressed rifles.

In addition to the posted closure signs, all residents who own property adjacent to Cleveland Metroparks property will be sent a letter informing them of the culling program. As in past years, venison will be donated to a local food bank.

Cleveland Metroparks has worked hard to insure that the deer management program is safe, humane and effective. Cleveland Metroparks also initiated a contraceptive field research project in 2001 in an effort to identify deer management alternatives. If you have questions, please contact me at (216) 635-3295.



No person shall stand or park a vehicle on sidewalk, curb, street lawn area, in front of a public or private driveway, within an intersection, within 10 feet of a fire hydrant; at any place where signs prohibit stopping, standing or parking within the Village of Glenwillow.


